LWVSCC Holds Education Study Meetings

On October 14 seventeen members of our local League attended the first of two consensus meetings on the LWVUS study on the "Role of the Federal Government in Public Education" at John and Sandy Warren's home in Santa Cruz. After refreshments, members introduced themselves with a brief background of their experience with the educational system. Committee member Joyce Aoyagi gave an excellent presentation on Core Standards and Assessments, then facilitator Barbara Lewis kept the discussion moving through the nine consensus questions; Sandy Warren recorded the consensus results. Members debated the merits of the various options, with ideas from many differing viewpoints represented, and eventually the group reached consensus on all nine questions before the meeting ended on time at 3 P.M.

At the second consensus meeting on October 28, attended by sixteen members, Jack Dilles presented information on Funding and Equity and Ann Wise facilitated. We came to consensus on all but one of the questions asked by the study.

The answers arrived at during both meetings will go to our local League Board for approval on November 8 before being submitted to the national League. From December 2011 to February 2012, the national League committee will analyze the data from League consensus meetings across the country, and then write the position paper for the "Role of the Federal Government in Public Education." In March 2012, the LWVUS Board of Directors will review the results for comment and approval of the position, which will form the basis of future action by LWVUS.

LWVUS President Speaks on National Public Radio

On October 17 LWVUS president Elisabeth MacNamara spoke about voter suppression as a guest on National Public Radio's call-in show, "On Point," hosted by Tom Ashbrook. The show focused on a new wave of state law changes that tighten voting laws by making registration more difficult, requiring photo ID or proof of citizenship to vote, reducing early voting opportunities, and disenfranchising ex-felons.

"We definitely view it as voter suppression, whatever the motivation," said Elisabeth MacNamara, national president of the non-partisan League of Women Voters. She said that the new laws are not only expensive to implement, but also amount to new and onerous government regulations with "almost no benefit from an integrity standpoint."

Campaign for a Healthy California Gets Started

On October 22, the California Nurses Association and Health Care for All, along with other co-sponsoring organizations (including the LWV of Santa Cruz County), kicked off the Campaign for a Healthy California to bring about Universal Single-Payer Healthcare for California at the Watsonville Civic Plaza Community Room.

Introduced by our knowledgeable County Treasurer Fred Keeley, the three excellent speakers were inspirational and convincing that California can succeed in adopting a universal single-payer health care system.

Donna Smith, of National Nurses United and featured in the movie *Sicko*, described her family's experience of nearly going bankrupt because of health care costs, even though they had health care insurance. She cited statistics that about 100,000 deaths per year are attributable to lack of access to health care in the United States, about 12,000 per year in California. In 2010, approximately 60% of the two million personal bankruptcies in the U.S. were due to medical crises affecting 1.2 million people: 2,990 per day in the U.S., 350 per day in California, causing significant impact on the economy. Smith also pointed out that currently 22 states are in various stages of enacting a single-payer health care system.

James Haslam, Executive Director of the Vermont Workers' Center, outlined the grassroots movement that enabled Vermont to get legislative approval and the governor's signature on a single-payer health care reform bill. Like California, Vermont had tried for many years to establish single-payer health care. In 2008, the campaign began to emphasize health care as a human right, moving the discussion from abstract facts and figures to personal testimony and concrete examples for saving lives. People were dying under the old system that was not so much focused on providing health care as it was structured to make money for investors.

During the course of the campaign in Vermont, 15 candidates forums were held that focused on health care as a human right and a public good. Efforts in the Senate to amend the bill to exclude undocumented workers, seen as hateful and racist, were vigorously opposed by the campaign and ultimately defeated. The campaign also refused to take out women's reproductive health when the Catholic Church threatened to pull a \$35,000 grant. What was said to be politically impossible proved to be possible. The lesson here, emphasized Haslam, is not to let elected officials determine what is politically possible. The single-payer health care bill passed with strong bi-partisan support that could have overridden a governor's veto. The Governor signed it.

Andrew McGuire, Executive Director of California One Care, believes that a similar campaign would be successful in California. Occupy Wall Street has changed the political context. The time is ripe to demand that all residents be given full health care coverage. McGuire thinks that the toughest opponents are people who believe that government programs do not work, but he definitely would not promote incremental steps that are flawed. He believes that any system that allows the private health insurance system to exist and expand will not succeed.

McGuire advocates a single-payer campaign strategy that focuses on getting a 2/3 vote in the Assembly and Senate, as opposed to a ballot initiative. He believes that trying to use the initiative process would be too expensive and too risky, given the enormous amount of money on the side of the health care insurance industry and pharmaceutical companies. McGuire described a five-step campaign strategy beginning at the local level to elect candidates who support a universal single-payer health care system for California.
